2. Executive Summary

Executive Summary

On the request of BullionStar Pte. Ltd., Bureau Veritas New Zealand visited the premises mentioned above on the 1st of July 2022 for the purpose of carrying out a stock inventory audit, random verification of serial numbered bars, and weighment sample of gold, silver and platinum products.

The gold, silver and platinum products were satisfactorily stored on the 2nd basement level in the Aon Centre, 1 Willis Street, Wellington 6011, New Zealand. The Vault is equipped with surveillance cameras, motion detectors, seismic detection, and comprehensive entry/exit access protocols.

The Vault is further equipped with a Chubb branded "treasury-grade" vault door. Inside, the bullion products are stored in reinforced Chubb 'Bankers Safes' (series 5) with two-person verification access as well as in reinforced locked cages atop of heavy-duty pallets.

A total 25,386 items, consisting of Gold Bars, Gold Coins, Silver Bars, Silver Coins, and Platinum Bars were inspected, counted, and verified to match the "*NZ Customer Stock*" document issued by BullionStar Pte. Ltd. on the 1st of July 2022.

A random sample of nine (9) customer vault accounts holding serial-numbered bullion bars for vault storage were further inspected to verify the correctness of the listed serial numbers based on the document: "Customer Stock Inventory of Customers New Zealand" issued by BullionStar Pte. Ltd. on the 1st of July 2022.

A random sample of ten (10) different products were weighed using a certified *Mettler Toledo* weighing scale for the purpose of weight verification.

It is concluded that as of 1st July 2022, the quantity, serial number, and weight of the bullion products inspected are accurate as outlined.

3. Inventory Stocktake

Inventory Stocktake

The Gold Bar, Gold Coin, Silver Bar, Silver Coin and Platinum Bar products were satisfactorily stored on the 2nd basement level in the Aon Centre, 1 Willis Street, Wellington 6011, New Zealand. The Vault is equipped with surveillance cameras, motion detectors, seismic detection and comprehensive entry/exit access protocols.

The Vault is further equipped with a Chubb branded "treasury-grade" vault door. Inside, the BullionStar products are stored in reinforced Chubb 'Bankers safes' (Series 5) with two-person verification access as well as in reinforced locked cages atop of heavy-duty pallets.

A total of 25,386 individual product items were inspected, counted and verified to match the "NZ Customer Stock" document issued by BullionStar Pte. Ltd. on the 1st July 2022.

The total quantity of customer products for each product category was counted and verified in accordance with the breakdown on the following page:

A random sample of nine (9) customer vault accounts holding serial-numbered bullion bars for vault storage were further inspected to verify the correctness of the listed serial numbers based on the document: "*Customer Stock Inventory of Customers New Zealand*" issued by BullionStar Pte. Ltd. on the 1st July 2022.

A random sample of ten (10) different bullion products were weighed using a certified Mettler Toledo weighing scale during the inspection for the purpose of weight verification. To ensure precision during verification, only items without packaging were weighed.
